## GOVERNMENT'S NOTICE OF DEFENDANT'S MEDICAL CONDITION PREVENTING ARRAIGNMENT

The United States of America, by John M. Haried, Assistant U.S. Attorney for the District of Colorado, hereby gives the Court notice that the defendant is suffering from a serious medical condition that has prevented the government from producing him in court today as scheduled, and states as follows:

- The defendant was arrested by the FBI on Thursday, October 16, 2008, on a warrant. The indictment is sealed.
- 2. When arrested, the defendant was very intoxicated. The U.S. Marshal could not accept the defendant into custody per policy because the defendant's blood alcohol level was .324 according to a field sobriety test.
- The FBI took the defendant to the Denver City Jail which was equipped to deal with intoxicated inmates.
- 4. Overnight, the Denver City Jail determined that the defendant's condition required immediate hospitalization for withdrawal from alcohol, and it sent him to

Denver Health Medical Center for treatment.

5. This morning, on Friday, October 17, and unaware of last night's events, the FBI

went to Denver City Jail to pick up the defendant and transport him to the U.S.

Marshal for appearance in court today. Denver Health Medical Center told the

Denver City Jail that the defendant needed 3 to 4 more days of hospitalization

before his medical condition would be stabilized.

6. The FBI will call Denver Health Medical Center each day until the defendant is

released from medical treatment, and the defendant will be brought to court at

the earliest opportunity.

7. The government is not aware of any attorney representing the defendant at this

time.
